

**GLOUCESTERSHIRE COUNTY COUNCIL
ON STREET PARKING ORDER 2017**

(VARIOUS ROADS) (TOWN OF NAILSWORTH, PARISHES OF WOODCHESTER, HORSLEY & KINGS STANLEY) (STROUD DISTRICT) (VARIATION) ORDER 2024

NOTICE is hereby given that Gloucestershire County Council intend to make a Variation Order under Sections 1, 2, 3, 4, & 5 of Part I and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers, the effect of which would vary the Gloucestershire County Council On Street Parking Order 2017 (the 2017 Order) by introducing/revoking the restrictions detailed in The Schedule below on various roads in the Town of Nailsworth & Parishes of Woodchester, Horsley & Kings Stanley.
